*Please note that tryout results will be announced on Saturday, April 29th. Candidates will be asked to return to the Main Gym at a time TBD the day of tryouts for team announcements. The results will also be posted on Monday, May 1, 2017 on the window of the ERHS Activities Office and on the Don Page.

Information for Pepster Candidates

I. Eligibility

- A. To prevent injury, a candidate must be physically prepared.
- B. To try out, academic grades must be a minimum of a 2.0 GPA no U's and no more than one N in citizenship, and receiving at least 20 credits. These grades and citizenship requirements must be reflected on the first semester report card or the third quarter progress report for high school students. No exceptions are allowed.
- C. Pepster candidates must be current or incoming El Rancho High School students.
- D. Points will be awarded for attendance, appearance and attitude at each workshop. Each of the five workshops will be worth 20 point, for a total of 100 points. If a candidate is absent for more than two classes, he/she may not attend that day's workshop. Workshop attendance points will be factored into each candidate's judging score.
- E. Points will be awarded for the teacher recommendation form. The candidate will receive 5-25 points equal to the rank received on the recommendation form. These points will be factored into each candidate's judging scores.
- F. School financial account must be in good standing with no overdue fees.

II. Workshop Sections

- A. Dates, times, and locations can be found on page 2 of the information packet.
- B. All workshops will be held on the El Rancho High School campus.
- C. Candidates must wear white shirt and blue/black/grey shorts with hair pulled back in a high ponytail. Tennis shoes (no vans or converse) must be worn at all times. Tank or midriff tops, denim shorts, or pants are not allowed. School dress code must be followed.
- D. The locker room will be open for changing clothes.
- E. Each candidate will be given a number that must be worn at all workshops.
- F. No jewelry may be worn at any time.

III. Procedure for Tryouts

- A. Preliminary tryouts for Yell Leader and Song Leader candidates will be held on the El Rancho High School campus.
- B. No one will be admitted into the gym during the tryout session except those trying out, the judges, the advisor(s), the Activities Director, and Administrators. **No**Exceptions!!!
- C. Each candidate must arrive promptly. Each candidate must be dressed in royal blue shorts, a white t-shirt, white socks, white tennis shoes, hair pulled back in a high ponytail and a royal blue bow.
- D. Candidates will tryout in the groups assigned to them during the workshops.
- E. Candidates will be able to leave after they tryout and asked to return at a time TBD the day of tryouts.

IV. Selection

- A. The tryout candidates for Song and Yell will be evaluated by a panel of USA judges only.
- B. Each candidate will be ranked from highest to lowest using the judge's scores, workshops points, and points from the teacher evaluations.
- C. Only current 9 11 grade students will be eligible to make the Varsity Pepster team. 8th grade students will only be eligible to make the JV Pepster team.

V. Judging

- A. Using a rubric similar to guidelines of the United Spirit Association, the panel of judges will evaluate each candidate on the following criteria: Grooming, Neatness, Poise, Posture, Timing, Rhythm, Knowledge of the Routine, Execution, Technique, and Showmanship.
- B. Each candidate will have the opportunity to earn, at most, 200 extra points to be added to their judging scores. 100 points for workshop and 75 points for their teacher recommendation form (3 recommendations @ 25pts each).
- C. Each candidate is required to submit **three** teacher recommendation forms. At least one recommendation form must be completed by a teacher whose class the candidate is currently enrolled. The remaining, two, recommendation forms may be completed by staff members of the candidate's choice. The point scale value is as follows; 5 points for each ranking level received, ex; ranking 3 = 15 points.

^{*}Any vacancy occurring in the positions before the school year begins may be filled by the nominee who received the next highest combined ranking in the respective position. If a vacancy occurs in the Pepster squad after the school year begins, the vacancy may be filled by the Advisor(s)/Coach(es) with a member of the Junior Varsity squad. If this occurs the new member must meet all financial obligations that have already been established.

PEPSTER AGREEMENT

VI. Practices

- A. Summer practice is mandatory.
- B. During the regular school year practices times and dates will vary. (Length and time of practices will vary depending on the current activity and academic schedules.)
- C. A Pepster must attend all practices.
- D. Pepsters must attend all pep rallies.
- E. Pepsters must attend at least 4 classes of the school day to participate in any after school practice or activity. Any absence must be cleared within 3 days with the attendance office.

VII. Games and Student Body Events

- A. Pepsters will perform at ALL varsity football games, ALL boys and girls league varsity basketball games, CIF games, as well as any other event required by the advisor, coaches, Activities Director, Athletic Director, or Administrator.
- B. Pepsters will provide their own transportation for all away basketball games.
- C. Transportation to certain away football games will be provided. A transportation plan will be given.
- D. All squads will appear at ANY game or event when the advisor/coaches or Activities Director requests their appearances.
- E. Pepsters must be on school provided transportation (when applicable) for all events (Football games, competitions, etc) in order to perform at the given event/activity.
- F. Each squad member must return from off-campus activities in the same car or bus they rode to the activity in unless prior arrangements are made between the parent(s) and the advisor.
- G. Members must be in attendance for any Saturday performances or activities.
- H. Any tardy to any game or event will guarantee that the Pepster will be penalized. Penalties may consist of benching, being removed from performances etc.
- I. Having a job will not constitute as an excuse from any Pepster activity, whether a practice or performance.

VIII. Participation

- A. Members must maintain a satisfactory attendance record. A cut to any class may be considered grounds for removal from the squad. Be on time to every class.
- B. Be willing to support and work all Pepster activities.
- C. Be willing to support **ALL** El Rancho High School athletic teams.
- D. Do not accept a job that will interfere with your full participation in the Pepster squad or with your schoolwork.
- E. You must obtain athletic clearance and are encouraged to purchase a student body (ASB) card <u>before</u> summer camp.
- F. You must adhere to all school standards as stated in the student handbook.

- G. You are responsible for setting a good example for the student body.
- H. You are expected to show school spirit and pride as a representative of the student body.
- I. Members must participate in all school spirit activities (ex. spirit days, pep rallies, etc) as presented.

IX. Uniforms

- A. Uniforms will be approved by the advisor and coaches.
- B. Uniforms, accessories, services will not be issued or provided to any Pepster until his/her balance is **paid in full**.

X. Appearance

- A. Once on the squad, hair must be one natural color. No unnatural hair dying, highlights, or extensions will be allowed.
- B. While in uniform, hair must be worn in a ponytail with all hair pulled back (no bangs) and with uniform ribbon unless otherwise instructed by the advisor(s).
- C. Make-up must be moderate. Dark lip color or outline is not allowed while in uniform.
- D. Jewelry may not be worn in uniform.
- E. Warm-up pants may not be worn under the Pepster skirt.
- F. While wearing the team warm-ups, wear the team shoes.
- G. Only the warm-up jacket or Pepster Varsity jacket may be worn while in uniform.
- H. While in uniform, nails must be worn with either clear nail polish, or a French manicure. **Acrylic nails are not acceptable at any time.**
- I. If any piece of the uniform is lost or damaged it is the responsibility of the Pepster to purchase a replacement piece as soon as possible.

XI. General Conduct

- A. Be a lady or gentlemen at all times.
- B. Be neat and well groomed at all times. Follow the school dress code as stated in the student handbook.
- C. Observe all rules of the school relating to conduct. Any violation of the schools behavior contract (as written in the student handbook), which results in suspension from school will result in permanent removal from the squad.
- D. Be friendly to other students and respectful of school faculty and staff.
- E. Profanity is not allowed.
- F. No smoking, drinking alcoholic beverages, or drug use at any time **on** or **off** campus. Evidence and/or admission of violating this rule will result in permanent removal from the squad.
- G. Be willing to sacrifice personal desires in order to set a good example for your squad.
- H. Be willing to take corrective criticism from advisor, captain(s) coaches, and team members.
- I. Always put the school above personal interests.
- J. Public displays of affection will be restricted to hand-holding only. A member who violates this rule will be benched. Repeated offenses in this area will be grounds for removal from the squad.

XII. Conduct in Uniform

- A. Gum chewing is prohibited.
- B. Uniform should be neat and clean.
- C. Shoes and socks should be neat, clean, and in good condition.
 Only the warm-up jacket or the Pepster Varsity jacket can be worn while in uniform.
- D. Members must wear hair and make-up according to the advisor and coaches instructions.
- E. Members must listen to instructions given by the bus driver at all times.

XIII. Conduct on the Field or Gym Floor

- A. During football games, Pepsters are to stand in an orderly fashion with good posture and their hands behind their back.
- B. No gum, food, or beverage is to be consumed on the field or in the stands unless approved by the advisor or coaches.
- C. Move to assigned positions with a sense of urgency.
- D. Do not interfere with players or coaches.
- E. No practicing or stretching in front of the audience unless approved by the advisor or coaches
- F. No applying make-up or doing hair in front of the audience.
- G. Adjust your uniform and briefs discretely. **Not in front of the audience.**
- H. Members must get permission from the advisor or coaches to be excused to the restroom during events. Only two members at a time will be excused. The team coaches and/or advisor must know where you are at all times.
- I. During half-time at all football games, members must notify the advisor and/or coaches if they will be leaving the field.
- J. Members must show respect and good sportsmanship toward opposing teams at all times.

XIV. Athletic Clearance

- A. Each new member must be athletically cleared before participating in first day of summer practice.
- B. Returning members have until June 23, 2017 to complete their 2017-2018 Athletic Clearance.
- C. To be athletically cleared: you must register with Family ID (online on the Don Page), Print the physical form, attain a physical (it must have a doctor's stamp or doctor's receipt attached), complete the online registration process, return physical forms and receipt from FamilyID to the Activities Office.

XV. Grades

- A. A Pepster must maintain a 2.0 GPA with no U's, and no more than one N, receive at least 20 credits at all grading periods.
- B. Any Pepster who fails to turn in grade checks (with parent signature) on assigned

- date to the advisor may be removed/benched from activities until the required grade check is submitted.
- C. A Pepster who does not meet these grade requirements during the Progress Report period will be placed on probation by the advisor. While on probation, a Pepster must comply with all of the terms of his/her probation. Violating the terms of the probation can result in permanent removal from the squad.
- D. A Pepster who does not meet the above grade requirements at the end of any semester will be permanently removed from the squad. NO EXCEPTIONS!!!
- E. Member's grades and difficulties in classes are their own responsibility. Regardless of the probation period or difficulties in classes, students are expected to participate in all events and practices. Please balance academics with extracurricular activities responsibly.

XVI. Finances

- A. Parents should understand before a student tries out for Pepsters that the cost of Pepsters is approximately \$2,000.All Pepsters must be responsible for meeting each financial deadline. Fundraisers may be held to raise money for group costs such as: stunt and technique classes, choreography, music, team apparel, team events and competition fees. Parents/guardians are responsible for all costs and should understand that any money not paid will become a fine on their student's account.
- B. A **NON-REFUNDABLE** deposit of \$400 will be required prior to the date of fitting (refer to master calendar). Any member who does not pay the deposit prior to the fitting will not be fitted for his/her uniform. Arrangements must be made by the parents with the uniform company for a late fitting. Please be aware that uniform companies make one trip to the school site and a delay in the fitting can mean a delay in the production of the uniform.

XVII. Sports

- A. Members may **NOT** participate in any other sport offered on campus.
- B. Active members must not transfer out of the Pepsters class at any time during the school year.

XVIII. Summer Camp

A. <u>Summer camp is MANDATORY for all Pepsters</u>. Failure to participate and be athletically cleared by the first day of camp will result in permanent removal from the squad. Camps are either hosted by the United Spirit Association at a specific off campus-location, or are held on the El Rancho High School campus. The dates and locations of camp are determined by the advisor and coaches. The camps are four days in length, and it is mandatory that each day is completely attended. The cost of the camp is approximately \$400 per person. The cost varies on the location and duration of the camp. Please note that camp uniforms are an additional cost.

XIX. Miscellaneous

A. Any mid-term graduate will be relieved of all Pepster responsibilities.

XX. Fundraising

- A. All fundraisers must be authorized by the Executive Commission two weeks prior to the event.
- B. Fundraiser must benefit all the students in the club or organization (no personal fundraisers).
- C. Individual students will be receipted for fundraiser monies at the cashier's office.
- D. Food sales are allowed 1 hour before school begins or 30 minutes after school ends. No food is allowed on campus. Please distribute foods items at the end of the school day; students should not be carrying items for sale on campus.
- E. Car washes are not allowed on campus until further notice (per ERUSD Business Office).
- F. Maximum number of days for any type of sale is 5 days.
- G. All fundraised monies must be paid to the Activities Office within 3 days of final approved date of fundraiser.

- 1. I will inform the coach of any physical disability or ailment that may affect the safety of my child or the safety of others.
- 2. I (and my guests) will be a positive role model for my child and encourage sportsmanship by showing respect and courtesy, and by demonstrating positive support for all players, coaches, officials and spectators at every game or performance
- 3. I (and my guests) will not engage in any kind of unsportsmanlike conduct with any official, coach, player or parent such as booing and taunting; refusing to shake hands; or using profane language or gestures.
- 4. I will not encourage any behaviors or practices that would endanger the health and well being of the athletes.
- 5. I will teach my child to always do her best, follow all rules and I will praise my child for always putting forth her best effort.
- 6. I will require that my child treat other cheerleaders, players, coaches, officials and spectators with respect regardless of race, creed, color, gender or ability.
- 7. I will not be negative or ridicule my child or other participants for making a mistake.

- --NOT BEING IN UNIFORM WHEN IT IS MANDATORY (this includes improper use of uniform and/or incorrect hair/bow/pieces of uniform)
- --FOUL LANGUAGE WHILE IN UNIFORM
- -- NAILS OR JEWELRY AT PRACTICE, GAME, OR PERFORMANCE
- --BREACHING ANY CONDUCT RULES OUTLINED IN SECTIONS: X-XV AND IN THE CODE OF CONDUCT
